- 1.2 The description includes past personal responses to Te Tiriti o Waitangi in terms of the influence of past sources of information, experiences, and influences.
- 1.3 The description includes present personal response to Te Tiriti o Waitangi.

#### Outcome 2

Outline the meaning of the articles of Te Tiriti o Waitangi for youth work.

Range evidence is required in relation to the articles of Te Tiriti o Waitangi.

#### Performance criteria

- 2.1 The description outlines Māori and Crown intentions in signing Te Tiriti o Waitangi in accordance with Māori and Crown oral and written sources.

2.2 The description outlines the differences in meaning between the Māori version and the English version of Te Tiriti o Waitangi.

2.3 The description outlines the relevance of Te Tiriti o Waitangi to youth work.

Range relevance – relationships with tangata whenua, relationships with tauwiwi, planning, policy, service delivery and provision, staffing; evidence is required of two.
