# Introduction

The Careerforce 3-year moderation plan (2024 – 2026) provides guidance to Careerforce assessors regarding the unit standards we seek to moderate over the coming 3 years.

Careerforce moderates assessment of unit standards to ensure that there is a consistent high standard of assessment practice being undertaken across the country and across the sectors we support. This serves to protect our trainees in the sector, and to improve health and wellbeing outcomes for those our learners support. Moderation is a continuous improvement process. Careerforce seeks to improve assessment practice and support assessors to excel in their roles.

Unit standards are scheduled in the 3-year plan based on the risk they present to the sectors they belong to, and the history of moderation of said standards. For these reasons, some standards will be scheduled in each of the three years. Unit standards are grouped in this moderation plan based on the assessment scope that they are aligned to. Specialist units from the various strands of qualifications may have been listed separate to their 'parent' qualification e.g. dental, and vision hearing screening unit standards.

To meet your moderation obligations, consider the unit standards that you find most difficult to assess and which you would appreciate most support with. Use the 'find' function (Ctrl+F) to search for the specific unit standards you would like support with. If they appear as a unit we wish to target in the current year then please submit a sample for moderation, or bring this to peer moderation. These units should be your highest priority for submission for moderation.

If the units you most want support for, or the units you have assessed, aren't in the current year we will still accept these for moderation.
