

Entry requirements for the **New Zealand Certificate in Health and Wellbeing (Advanced Care and Support) (Level 4)**

Careerforce wants trainees to be successful in their training and to gain their qualification. One of the ways we do this is to have programme entry requirements.

The entry requirement for this Health and Wellbeing qualification ensures that trainees have the prerequisite knowledge and skills needed to be successful during their training.

What are the entry requirements?

The trainee must be able to show they have the equivalent skills and knowledge to enrol in the programme by meeting one of the following entry requirements:

- New Zealand Certificate in Health and Wellbeing (Level 3) [Ref: 2470]
OR
- National Certificate in Health, Disability, and Aged Support (Core Competencies) (Level 3) [Ref: 1327].
OR
- National Certificate in Health, Disability, and Aged Support (Health Assistants) (Level 3) (Healthcare Assistance strand) [Ref: 1677].
OR
- an Attestation from the trainee's current employer that the trainee can demonstrate equivalent experience, skills and knowledge to the prerequisite qualifications listed above.

Enrolment process

If the trainee holds one of the prerequisite qualifications listed above, complete the Training Agreement and forward it to Careerforce. Careerforce will carry out a qualification check as part of the enrolment process.

If a prerequisite qualification has not been achieved, the trainee must have the equivalent experience. The trainee's current Employer must complete an Attestation that confirms that the trainee can demonstrate equivalent experience, skills and knowledge. The form is on the next page.

The enrolment process cannot proceed without the entry requirements being met.
